

GROUND SPACE REGATTA DAY 2009

All persons and organizations wishing to rent ground space for the 2009 Royal St. John's Regatta are advised of the following procedures:

APPLICATION PROCEDURES

1. All persons and organizations requesting ground space must fill in this application form and submit it to the address noted below.
2. Deadline for receipt of application is **July 29, 2009**. Concessionaires from the 2008 Royal St. John's Regatta will have first right of refusal to last year's location providing the application is received by the deadline date. All applications will be date stamped and new concessionaires will be placed in the order their applications are received. All applications will be accepted. The exact location of your concession within the zone is at the discretion of the Royal St. John's Regatta Committee.
3. All concessionaires are reminded of the Provincial Department of Justice regulations concerning gaming concessions and the Provincial Department of Health regulations for food concessions. For further information please contact:

4. Permits will not be issued to individuals, organizations or non-profit groups conducting a lottery unless they are in possession of a lottery license issued by the Department of Justice.
5. Separate application forms for each concession is required.
6. No payment is to be sent with application.
7. Concessionaires are reminded that wheeled vehicles are not permitted as concessions on grassed area during Regatta Day, except as agreed by the Ground Space Committee Chairperson.
8. Generators used by concessions must not be noisy or be located in an area that proves hazardous to the public.
9. The Royal St. John's Regatta Committee **CANNOT** guarantee that concessionaires will be in the exact location as previous years; concessionaires will be in the general area.
10. Concessionaires are responsible for cleaning their own ground space area, providing trashcans, etc.
11. Concessionaires must remain stationary.
12. Parking permits **will not** be issued to concessionaires.
13. The Royal St. John's Regatta Committee is not responsible for booths left unattended or damaged.
14. Cash prizes are not allowed for Games of Chance, except with Crown and Anchor, which can only be operated by a Charitable Organization.
15. The Royal St. John's Regatta Committee strongly encourages a smoke-free event. Please be respectful to all in attendance at the 2009 Royal St. John's Regatta and only smoke in the designated smoking areas.
